**HEALTH AND SAFETY PROTOCOLS**

- Sweet Adelines International's 74th Annual Convention and Competition 2022 will be a fully-vaccinated event, with the exception of those with qualifying exemptions. Documentation and verification are required for attendance. Booster shots are recommended, when eligible.
- You must have received your final vaccine shot by August 22, 2022 to be considered fully-vaccinated for Convention.
- Masking requirements as well as additional health and safety protocols will be determined at a later date with consideration of current local, national and venue recommendations, mandates and guidelines.
- A trusted third-party company will handle the upload and verification of all vaccination and exemption documentation. Proof of vaccination is not required at time of registration. Registrants will be contacted via email closer to the event to upload their proof of vaccination. Registrants wishing to file a medical or religious exemption will be contacted separately.
- Sweet Adelines International reserves the right to adjust health and safety protocols based on the status of COVID-19 at the time of the event.

- Pre-Registration closes July 15, 2022. After this date, seating will be assigned based on availability.
- Registrations can be purchased online until August 22, 2022. After August 22, registrations can only be purchased in person at the event.
