The arrangements performed must be listed in the Song Evaluation Database (or Parodies list available to judges) as a YES (Yes, Yes: Note,

Yes: Caution, Yes: Lyrics). Any arrangement performed in contest that is found to have NOT received a YES rating or that does not heed the

stipulations noted for Yes: Lyrics and Yes: Caution ratings will result in the performer being disqualified.
