FAQs for Members

When will my renewal be due?

You will keep the same renewal date and stay on the same billing cycle; however, your grace period to pay following your renewal date will be five months or 150 days, through June. If your renewal date is July 1 or later, the grace period extension decreases in increments of 30 days; please view chart.

FAQs for Chapters

What if our chapter does not have enough members (12) to renew?

Sweet Adelines International has a Revitalization program that has proven to be successful in supporting small or struggling choruses. When is the 2020-21 chapter renewal period?

Chapter invoices will be available to pay on May 1. The renewal period has been extended by 30 days and will end on July 30. If your chapter has concerns, please contact Valerie Renz at valerie@sweetadelines.com.

How can we have our elections if we are not meeting in person?

Per policy, absentee ballots can be cast electronically. During this time, the entire chorus may vote absentee. Additionally, policy does provide room for postponing your election:

Section 1. MEMBERSHIP

- A. The Management Team (Board of Directors) shall consist of four (4) to eight (8) elected members plus the Musical Director (even if a non-member) with the option to appoint up to three (3) additional members. Their term of office shall be for one (1) year or two (2) years as defined in the chapter standing rules (except for the Musical Director) or until their successors are elected/appointed.

Can our chorus create a fund to help those unable to pay during this time?

Yes. We are working on guidance and will provide information soon.

FAQs for Quartets

When will the invoices for quartets become available?

Quartet invoices will be available to pay on May 1. The renewal period has been extended by 30 days and will be due by August 31, 2020.

What is the cost of renewal?

The International Board of Directors has approved a discounted registration fee of \$50 USD for quartets during the months of May and June. On July 1, the renewal will be \$100 USD.
