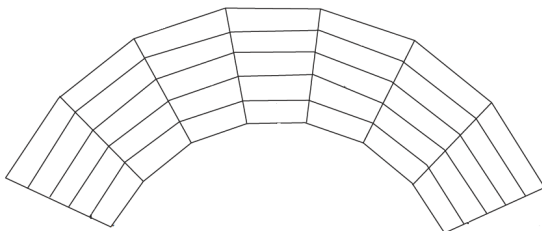

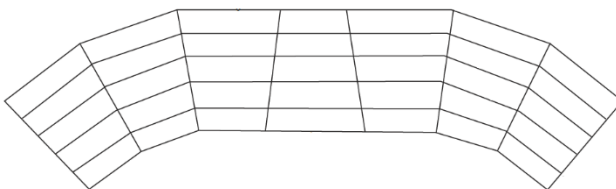
RISER SELECTION

Each region selects the riser configuration(s) that they will offer. If your region offers multiple riser configurations, you **MUST** choose one. If one is NOT checked, you are automatically placed on the **INVERTED** risers. A **\$50.00 USD fee** is assessed if your chorus changes its riser configuration after the initial draw for order of appearance. The chorus is also treated as a late entry and sings at the beginning of the appropriate session. **Contact your Competition Coordinator for the riser configuration information.**

CONTEST DIVISION: (Please choose one)

- ☐ **International Division:** Competing for placement and medals with two competition songs. This is the only division that allows competitors to qualify for international competitions.
- ☐ **Evaluation Only:** Competitors perform two competition songs, not for placement. **(NEW:** Evaluation Only competitors NO LONGER perform before International Division competitors. These competitors will now be drawn at random, interspersed between the International Division and Open Division competitors as determined by the Competition Department at IHQ.)
- ☐ **Open Division:** Competing for evaluation (level score awarded) with a performance package consisting of one competition song, emcee work, and at least one non-competition song. Performance is limited to 10 minutes.
- ☐ **Video Evaluation:** Same as Evaluation Only, except performers submit a pre-recorded performance for the judges to review.
- ☐ **Video Open Division:** Same as Open Division, except performers submit a pre-recorded performance for the judges to review.
- ☐ **Evaluation Only: Internationally Bound (only choruses competing at the current year's International Chorus Semifinals or Harmony Classic are eligible for this division):** Competing for evaluation with a performance package consisting of one competition song, emcee work, and at least one non-competition song. Performance is listed to 15 minutes.

SONG ASSESSMENT

Prior to their performance, all songs performed by competitors are required to receive an admissible rating through the Song Assessment Tool. The arrangements performed must be listed in the Song Evaluation Database (or Parodies list available to judges) as a **YES** (Yes, Yes: Note, Yes: Caution, Yes: Lyrics). Any arrangement performed in contest that is found to have NOT received a **YES** rating or that does not heed the stipulations noted for Yes: Lyrics and Yes: Caution ratings will result in the performance being immediately stopped and the performer being disqualified.
